



(Arizona Radiation Regulatory Agency) Fukushima Experience: In the afternoon of March 11, 2011, a 9.0 magnitude earthquake occurred off the Pacific Coast of Japan, causing 15-meter tsunami waves that overwhelmed the protective seawalls of the Tohoku region. The earthquake and subsequent tsunami alone constitute one of the worst natural disasters in Japan's history, with more than 20,000 victims and a projected cost of over \$300 billion. What do we do now? Do current nuclear plant safety goals adequately reflect the socioeconomic impact of wide-scale contamination events?

The applications of nano-based technology in the food industry may include nanoparticulate delivery systems, food safety, biosecurity, and nanotoxicity. Although nanotechnology has been around since the 1950's, its recent explosion into the marketplace has created new products and applications in food safety. However, like many new technologies, the laws and regulations governing such technologies are few, and there are concerns about ethics, safety, and environmental protection. This presentation provides attendees with: (1) an introduction to nanotechnology, (2) its worldwide market potential, (3) potential impacts on food safety, and (4) ethics and regulation concerns. 2:00 - 2:50 PM Common Foods Prepared in Carnicerias David Morales (Maricopa County Environmental Services Department) Hispanics live throughout the United States; states like Arizona, California, Texas and New Mexico have some of the largest populations out West. The Hispanic population is very loyal to the food of their homeland. Inspectors are familiar with tacos, tostadas, burritos and rice & beans, but as the demand for some of the more authentic foods grow so does the uncertainty in the processes for the inspector. Items such as the tortilla making process starting from a corn kernel, the various types of pork rinds and their derivatives, the making of chorizo/longaniza, and the ever important aspect of making sure products are being obtained from an approved source. 2:50 - 3:20 PM Break - Visit Exhibits Viruses in Groundwater: National Occurrence and Impact Endemic on Waterborne Disease 3:20 - 4:10 PM Dr. Chuck Gerba (University of Arizona) Pathogenic enteric viruses have been detected in from 20 to 40% of drinking water wells in the United States used by utilities. In non-disinfected groundwater drinking water systems these viruses have been found to account for ~30% of gastroenteritis in the communities which they serve. This year the USEPA will ask drinking water utilities, which use groundwater as a source of drinking water, to begin monitoring for entero and noro viruses as an unregulated contaminate. Understanding Coccidioidomycosis in Arizona 4:10 - 5:00 PM Clarisse Tsang (Arizona Department of Health Services) Coccidioidomycosis, or Valley Fever, is a fungal disease that is endemic in the American Southwest; in Arizona alone, there were over 16,000 cases reported in 2011. With reported cases on the rise, and limited understanding of the disease risk factors, this session hopes to explain the biology, detection, epidemiology and prevention of this environmental non-communicable disease, and its association with dust and mining activities. 5:00 - 6:30 PM **Exhibits & Mixer**

2:20 - 3:10 PM Validation of Exposure Tools to Assess Recreational Swimmers

Laura Suppes

(Student, University of Arizona)

Current survey tools lack assessment of a variety of contributing swimmer exposure factors including activities associated with site- or scenario-specific events. The overall goal of this project was to develop a questionnaire to accurately assess swimmer exposures that might lead to adverse health outcomes; and evaluate the role of pool/spa design and operations in risk mitigation. The outcome of this project is a database of questions that can be used in future epidemiological research and outbreak studies. The tool will be widely disseminated and available to researchers, enabling consistent collection of swimming pool/spa exposure data for future comparisons.

### 3:10 - 4:00 PM Different Refrigerators for Differing Tasks: A Look at NSF/ANSI 7

Ron Grimes (NSF)

This presentation is designed to allow the sanitarian in the field to recognize common refrigerator/ freezer types, and construction requirements for units certified to NSF/ANSI 7 and their use for commercial food equipment. With this understanding of testing and protocol, the public health limitations placed on the equipment can be better understood. Attendees with experience in the basic construction aspects of commercial food equipment might benefit most.

Attendees of the presentation will better understand the various requirements for certification of a product to the NSF/ANSI 7 Refrigeration Standard. In addition the presentation will attempt to differentiate the relationship between the different types and uses of refrigerators and freezers. With this information attendees will have the ability to identify (recognize) how to determine the certification limitations during the plan review phase on product storage. Understanding the certification process should help in addressing problems encountered with certified refrigeration equipment.

### 4:00 - 4:50 PM Regional Sustainability: Quality Infill Development Along the Light Rail Corridor

Bonnie Richardson (City of Tempe)

For far too long, most of Arizona's politicians and business leaders did not deviate from our state's historical "boom and bust" development patterns. Our suburban sprawl illustrated the unintended consequences of reaching out into the desert to build cheap housing and the attendant infrastructure for a lifestyle based on the automobile. Then, the housing market crashed, big banks needed a bailout and our sprawl-centered economy was exposed to its core. A paradigm shift was needed, and the Sustainable Communities Collaboration was launched.

### Ronald Dalrymple

Ronald Dalrymple started in State Service in 1982 when he was hired to implement an investigation and enforcement program for the Board that was acceptable to the state legislature. In 1983, he was appointed as the Executive Director. Mr. Dalrymple is the former Police Chief of Paradise Valley and has over 40 years of law enforcement experience and is currently a Reserve Lieutenant with the Tolleson Police Department.

Mr. Dalrymple has a Bachelor Degree from ASU in Political Science and a Master's Degree from ASU in Criminal Justice Administration with an emphasis in business management. He is also a Certified Public Manager. Mr. Dalrymple was appointed by the Governor to the joint legislative committee overseeing the new residential drug laboratory remediation program by the Governor. He has been responsible for the Board of Technical Registration drug lab remediation program from its inception.

### Jim Dingman

Jim Dingman has been employed by Underwriters Laboratories in Northbrook, Illinois since 1998. He is a Lead Regulatory Engineer in the Regulatory Services Department. He coordinates regulatory activities for UL's Environmental & Public Health programs, including drinking water additives, system components, food safety, and swimming pool equipment.

Prior to working at UL, Jim was employed by Tri-County Health Department in the Denver Colorado area for 16 years; last serving as their Education and Enforcement Coordinator. In this position, he was responsible for enforcement actions and hearings against non-compliant establishments, as well as providing educational opportunities – for both environmental health staff, and employees of regulated facilities.

Jim served two terms as President of the Colorado Environmental Health Association and also served as President of the Colorado Public Health Association. Jim is a Past President and honorary life member of NEHA. He is also a Diplomate Laureate in the American Academy of Sanitarians. He is on the Board of Directors of the Lake County Environmental Health Advisory Council, and serves as a site manager for the Lake County Medical Reserves Corps.

He serves on numerous boards and consulting projects because - as he has been told - he thinks differently. His intellectual interests range from Quantum Physics to Philosophy to Chaos Theory.

### Marlene E. Gaither

Marlene E. Gaither is the Environmental Health Program Manager for Coconino County Public Health Services District, and has worked for the County for the last 29 years in Environmental Health. She teaches at Northern Arizona University and has done so for the last 10 years. Marlene currently teaches HS 200 Healthy Lifestyles, and has taught HS 300 Human Diseases, HS 490 Environmental Health and HS 500 Current Health Issues.

Marlene is an active member of the Northern Arizona University Institutional Biosafety Committee, the National Environmental Health Association, Science Committee for the Conference for Food Protection, and the Arizona Environmental Health Association.

During her time with the county she has partnered with other agencies, such as the University of Arizona, Translational Genomic research Institute (TGen), Northern Arizona University, Grand Canyon Park Service, Centers for Disease Control, Arizona Department of Health Services, and US Department of Agriculture in an effort to conduct research to gain a better understanding about some of the major health issues we have encountered.

### Chuck Gerba

He has been an author on more than 500 articles including several books in environmental microbiology and pollution science.

### John Marcello

John Marcello is the Pacific Region Retail Food Specialist with the U.S. Food and Drug Administration. He is one of six FDA Regional Food Specialists assigned to the 9 state/2 territories Pacific Region. Regional Food Specialists provide technical assistance to regulatory and industry food safety professionals; train and standardize regulatory personnel, and provide consultation on nationally recognize standards for state/local/tribal retail food protection programs.
